4. It is expressly stipulated that this permit is a license for permissive use only and that the

placing of facilities upon public property pursuant to this permit shall not operate to create or vest any property right in any said holder.

5. Whenever necessary for the construction, repair, improvement, maintenance, safe and efficient operation, alteration or relocation of all or any portion of said highway as determined by Walton County any or all said poles, wires, pipes, cables or facilities and appurtenances authorized thereunder, shall immediately be removed from said highway or reset or relocated heron as required by Walton county and at the expense of permittee unless reimbursement is authorized.
6. All work shall meet county standards. Any revisions to the approved plans must be submitted to Public Works for written approval prior to any work being done.
7. All materials and equipment shall be subject to the inspection by the county engineer,
8. All County property shall be restored to its original condition as far as practical, in keeping with county specifications, and in a manner satisfactory to the County.
9. All installations shall conform to the County's specifications in effect the day the permit is issued.
10. **A plan covering details of the installation shall be made part of the permit.**
11. The permittee shall commence actual construction in good faith within 90 days, and shall be completed in 120 days.
12. The construction and maintenance of such utility shall not interfere with the property rights of a prior permittee.

16. It is understood and agreed the rights and privileges herein set out are granted to the extent of the County's right, title, and interest in the land to be entered upon and used by the holder and the holder will, at all times assume all risk of an indemnify, defend and save harmless the County of Walton and against any and all loss, damage, cost or expense arising in any manner on account of the exercise or attempted exercises by said holder of the afore-said rights and privileges.
17. During construction, all safety regulations of the County shall be observed and the holder must take measures including placing and display of safety devices that may be necessary in order to safely conduct the public through the project area in accordance with the

County's regulations.

18. **The office of the engineer designated in paragraph six (6) shall be notified twenty-four (24) hours prior to starting work and again immediately upon completion of work.**
19. In case of noncompliance with the County's requirements this permit is void and the facility will have to be brought into compliance or removed from the road way at no cost to the County.
20. Application must be accompanied by proof of permit or exemption from the Florida Department of Environmental Protection (DEP) **AND** the U.S. Army Corps of Engineers for work to be performed.
